SUBJECT: Off-Limits Establishments

1. Paramount to the welfare of our military personnel is good order, discipline, health, morale, and safety; to that end the following establishments in and around the City of Del Rio, TX are designated as off-limits to Armed Forces personnel:

2. The following establishments in and around the City of San Antonio, TX are designated off-limits to Armed Forces personnel:

3. The following establishment in and around the City of San Angelo, TX is designated off-limits to Armed Forces personnel:

4. The above establishments and areas were placed off-limits based on information obtained through the Laughlin Air Force Base (LAFB) Armed Forces Disciplinary Control Board. The establishment of off-limits areas is a function of command used to help maintain the health, safety, welfare, morale and discipline of Armed Forces personnel assigned and/or located at LAFB, pursuant to the authority contained in AFJI 31-213, *Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations*, dated 27 July 2006.

5. The 47th Flying Training Wing Commander has extended the off-limit establishments to include those located in the City of San Antonio and the City of San Angelo, which were placed off-limits based on information obtained through the Armed Forces Disciplinary Control Boards of Joint Base San Antonio (JBSA) and Goodfellow AFB.

6. The Armed Forces Disciplinary Control Board reminds members that in addition to U.S. Code Title 21, Section 863, the Uniform Code of Military Justice, Department of Defense policy, and Department of the Air Force regulations, the Texas Controlled Substances Act prohibits the sale, purchase, and possession of any drug paraphernalia. The Board cautions all military members to not enter any establishment that sells drug paraphernalia and to leave a business if they discover drug paraphernalia advertised or on display.

7. This permanent off-limits listing shall be briefed at all newcomer's orientations, commander's calls, and posted on unit bulletin boards. Distribute this information to all subordinate and mission partner units.

8. Military personnel assigned or attached to Laughlin AFB, or those transiting the Cities of Del Rio, San Antonio, and/or San Angelo, are prohibited from entering all establishments and areas declared to be off-limits. Military personnel who defy this prohibition are in violation of a lawful order and are subject to apprehension and prosecution for violation of Article 92 of the Uniform Code of Military Justice (UCMJ).
